Minutes of the 8" meeting of the Expert Committee on the matter relating to the schemes under Green City Mission held on 20.06.2019 at 12-00 noon in the Conference Hall (5"" floor) of UD&MA Department, "Nagarayan", DF-8, Sector-I, Bidhannagar, Kolkata-64.

Present: The participants present in the meeting are enclosed.

The meeting was initiated by the member convenor of the Committee with a brief discussion on the agenda relating to standardization of installation of the LED Lights Projects and High Mast and installation of CCMS in different ULBs/Development Authorities under Gree 1 City Mission. Agenda wise thorough discussion was held and the following decisions have been taken:

1. Technical Specification of LED Light and High Mast

Kolkata Metropolitan Development Authority (KMDA) has submitted a Technical Specification of LED Light and Hign Mast after consultation with leading Agencies in the Workshop dated 12.06.2019. The said specification has been discussed thoroughly.

Decision: The House unanimously approved the said Technical Specification. .

2. Standardization of LED Street Light and High Mast Project:

The present policy of the Government retarding Street Light is to replace the existing conventional lights by LED light fo Energy Efficiency purpose in a most economic and systematic technical way tu achieve best performance through modern technigue.. For implementation of the said policy, various ULBs/Development Authorities are keen towards installing LED Street Lights and High Mast Lights within their locality in different manners. Now it has become necessary to standardize the said LED Street Lights installation and High Mast Lights projects through one unique technical procedure. To standardize the LED Street Lights and High Mast Lights projects, the following decisions have been taken:

- a) The Detailed Project Report (DPR) should be prepared on the basis of proper survey by the competent authority to be deputed by the ULB/Development Authority at his own cost. Survey may be dc 1e taking into consideration the width of the road, its importance, distance between poles etc. and LUX level should be as per IS. All designs, calculation and relevant papers are to be submitted with the DPR for due vetting by the competent authority.
- b) Specification of the luminaries will be as per approved Technical Specification which is being communicated shortly.
- c) Selection of lumen of different luminaries will be as per BIS considering the type of road and its importance.
- d) There may be dimming facility in the LED light and High Mast Projects in specific locations may be adopted subject to approval from the ULB / Development Authority.
- e) Dimming of light (both LED Light & High Mast) will be made on 90 Watt and above Light.
- f) Original Equipment Manufacturer (OEM) will fulfil technical qualifications as per NIT for participating in the tender.
 OEM should provide their rates on 50% Capex payment and balance 50% 7 years annuity payment and upfront basis also on the specified product.
- g) Factory inspection by the Expert Committee from time to time is mandatory to ascertain the quality and standard of LED luminary as well as to ascertain about other quality control parameters of the manufacturer itself
 - 1. Manufacturer, enlisted suppliers of PWD. Dte, Govt. Bonafide outsiders, Reputed firm, Engineers Co-Operative having sufficient experience of similar type of supply works executed under Government/Semi Government, ULB's, Public Sector, Government autonomous body within last 5(five) financial years (FY 2014-2015 to FY 2018-2019) Date should be reckoned from the tender, PAN card., GST registration, Professional Tax Clearance Certificate and Valid trade license. MOU / Joint Venture/ sub contract in any form will not be allowed or provided in this contract.
 - 2. In the event of e-filling, intending bidder may download the tender documents from the website: http://etender.wb.nic.in directly with the help of digital signature certificate has to be deposited by the bidder through the following payment mode as per memorandum of the finance department vide no.3975-F(Y) dated 28th july, 2016.
